



DEWATER PERMIT

This permit allows the holder to discharge uncontaminated water (both storm and non-storm) into ACHD's storm drain system provided that the type of water discharged is authorized in, and remains at all times compliant with, ACHD MS4 (CWA NPDES) Permit No. IDS-027561, and any future amendments thereto, or subsequent versions thereof (the "NPDES Permit").

THE FOLLOWING REQUIREMENTS MUST BE MET:

1. The discharge shall not cause flooding of or damage to the street or otherwise exceed the available capacity of the MS4 storm drain system.
2. The permittee is authorized to discharge only: (a) those types or classes of non-storm water described and defined in NPDES Permit Section I.D.1(c); and (b) storm water surface run-off from the permittee's property into ACHD's MS4 storm drain system. No other discharges or discharge pathways are authorized under this Permit. Further, permittee shall not discharge any water, substance, or other material into the MS4 storm drain system that causes, or has the reasonable potential to cause or contribute to an excursion violating applicable Idaho Water Quality Standards, or that otherwise violates, or threatens the violation of, the terms of ACHD's NPDES Permit.
3. The discharge shall be treated to remove sediment prior to discharge to the storm drain system.
4. The discharge shall not contain an oily sheen. If oil sheen is present on the water surface, the water must be pumped, hauled and disposed of properly, or discharged to the separate sanitary sewer system.
5. Nothing in this permit authorizes or grants discharge rights to the separate sanitary sewer system. If discharge to the sanitary sewer system is required, Permittee shall obtain the written consent of the owner of, or jurisdiction governing, the sanitary sewer system prior to discharge.
6. The discharge shall not impair the water body to which the storm drain system discharges.
7. The discharge shall not harm ACHD's storm drain system or roadway system.
8. Piping to a discharge point across ACHD's right-of-way shall conform to all applicable requirements, codes, and standards including, but not limited to, traffic control devices and applications and adherence to all requisite public safety standards.
9. Permittee acknowledges and agrees that the MS4 storm drain system into which discharge is governed by this permit is the property of (i.e., is owned, operated and maintained by) ACHD. Consequently, ACHD reserves the right and sole discretion to revoke, deny or terminate any discharge under this permit.
10. The permittee accepts ultimate responsibility for the quality of water being discharged into ACHD's MS4 storm drain system, and agrees to defend, indemnify and hold ACHD harmless for any and all claims or damages resulting from the discharge, including without limitation violations of the ACHD's NPDES Permit or any other applicable law or regulation.

11. Issuance of this Dewater Permit does not exempt permittee from the requirements of applying for and receiving a License Agreement for any structures or facilities placed in the public right of way or a Temporary Highway Use Permit from ACHD, if required.
12. Per section 6007.4.1.4 of the ACHD Policy Manual, the fee for issuance of the Dewater Permit is either the \$900 Annual Fee or a \$75 per occurrence fee (good for any single event within 30 days of Dewater Permit issuance).

The permit holder agrees to employ Best Management Practices (BMPs) for the proper management and control of discharge.

Should the BMPs employed by the permit holder prove, in the sole discretion of ACHD, insufficient or not functioning to acceptable levels, ACHD may impose additional BMP requirements to mitigate for any perceived deficiency.

Permittee further agrees to comply with all amended, subsequent and/or future ACHD policies and ordinances as such are available and set forth at: <http://www.achdidaho.org/AboutACHD/PolicyManual.aspx>, and permits (including the NPDES Permit) having any bearing upon, or otherwise governing any aspect of, the discharge permitted herein.

Permittee acknowledges and agrees that when repair or replacement of MS4 infrastructure is necessary, permittee's discharge to the MS4 under this permit may need to cease during the time of repair or replacement. Permittee agrees to cease discharge for any period of time and for any reason when requested by ACHD or any other entity with jurisdiction under the Clean Water Act, including those with jurisdiction under ACHD's NPDES Permit. ACHD will provide as much advance notice to permittee as is practicable. Further, permittee must immediately cease any and all discharge permitted herein in the event said discharge results in a violation, or threatened violation, of ACHD's NPDES Permit. The permittee's discharge contemplated in this Permit shall not resume until subsequently authorized in writing by ACHD

If this permit is revoked, the permittee agrees to immediately halt all activity that may cause a discharge into ACHD's MS4 storm drain system. If this permit is revoked, then any applicable License Agreement shall automatically terminate. If the permit is revoked, the permittee must reapply and obtain a new permit, and comply with any additional conditions of discharge required by the District.
