Sealed proposals for 2022 Stormwater Basin and Swale Vegetation Management Services (SB&SVMS) Requests for Proposals (RFP) will be received at the office of the Ada County Highway District (ACHD) located at 3775 Adams Street in Garden City, Idaho, until 3:00 p.m. (Mountain Standard Time) on September 22, 2021, at which time proposals will be publicly opened via Zoom.

Please note that Proposal Cost will be considered with Evaluation Criteria for the award of a Service Agreement.

The RFP seeks competitive proposals from firms qualified to manage and maintain vegetation within ACHD Stormwater Basins and Swales at various locations within Ada County.

All prospective respondents are strongly encouraged to attend an RFP Pre-Submission Meeting and Proposal Workshop at 10:00 a.m. on September 15, 2021. As part of this Pre-Submission Meeting, ACHD will provide a workshop to attending respondents concerning the preparation and submission of their proposals. Prospective respondents will meet via Zoom. **Although participation in the RFP Pre-Submission Meeting and Proposal Workshop is voluntary, prospective respondents are encouraged to attend as it will be the only opportunity, aside from written inquiry and/or clarification requests, to obtain important information concerning this procurement.**

All questions or clarifications concerning the content and requirements of RFP must be submitted and received in writing by no later than 4:30 p.m. on September 14, 2021.
