Why Evaluate Service Providers/Sub-Contractors?

- Scores from these evaluations factor into "Past Performance" ratings that are used to assist in determining selection of service providers for future awards.
- Meaningful evaluations help ACHD to provide feedback to service providers to improve future performance and, thereby, award to the very best people and firms.

How to Evaluate Service Providers/Sub-Contractors:

- When assessing the schedule completion, address ACHD delays, if any.
- Ratings should be based on notes, observations, and other experience germane to the performance on the current project.
- Score accurately. A score of four (4) is respectable, however, a score of five (5) is exceptional and should used judiciously.

When to Evaluate Service Providers /Sub-Contractors:

 Always complete the Professional Services Evaluation Form within a reasonable period of time following the project's completion. All Sub-Contractors with significant project participation, i.e., more than \$50,000, should also be evaluated.
