1. Self-Evaluation Recommended Actions

A review of current ACHD policies, services, programs, and activities was conducted based on meetings with staff and responses to the program accessibility questionnaire. This section of the appendix summarizes the recommended strategies for implementing barrier removal actions, organized according to the categories identified in section 2 of the plan.

Accessible/Adaptive Equipment

- Review equipment provided by ACHD for use by the public, such as computers, copy machines, telephones, or other technologies, to identify potential barriers to accessibility and corresponding solutions.
- Collaborate with community organizations that serve people with disabilities to develop and maintain a resource list of assistive technology and accessible equipment.
- Establish and maintain a toolkit of adaptive aids and resources for staff who interact with the public. Include information about both onsite and contracted services.
- Include accessibility as a criterion for purchasing equipment such as furniture, site furnishings, and office systems. Whenever possible, evaluate furniture and building material purchases for compatibility with a wide range of disabilities and sensitivities.

Customer Service

- Develop a process for determining reasonable modifications as they are requested. The process should address the following considerations and/or steps:
 - Ensure the public has easy access to information about how to make a request for modifications and who to contact.
 - Ensure all staff can direct a person making a request to the appropriate staff member.
 - Ensure requests can be accepted from someone on behalf of the person with a disability and are not be required to be in writing.
 - Meet with the individual with a disability to identify which aspects of the program limit participation and what modifications can be made.
 - Document the modification(s) that was offered and the response of the person with the disability to the modification(s) offered. This documentation should be filed with the ADA Coordinator's office.
 - If individuals with a disability are not satisfied with the results of this process, they should be directed to ACHD's ADA Grievance Procedure.
- Assess the composition and needs of the population of people with disabilities. Take the necessary steps to improve communication and outreach to increase the participation of community members with disabilities in all ACHD programs and activities. Develop partnerships with organizations that provide services to people with disabilities.

- Track all accessibility requests. Analyze periodically to look for global issues that can be addressed and problems that can be solved proactively.
- Publicize efforts to increase participation of people with disabilities.

Notice Requirements

- To meet title II notice requirements, adopt the “Model Notice Provided by the Department of Justice.”
- Due to the complexity of the current ACHD grievance procedure, consider adopting the Department of Justice’s model.
- Establish a standard advance-notice requirement for all departments, programs, and services. Provide notice of the availability of program modifications, alternative formats of materials, and auxiliary aids. Include contact information for the ADA Coordinator and the advance-notice requirements.
- Include a nondiscrimination notice in ACHD hard copy and web publications:

The Ada County Highway District does not discriminate on the basis of disability in the admissions or access to its programs or activities. An ADA Coordinator has been designated to coordinate compliance with the non-discrimination requirements contained in the Department of Justice regulations implementing Subtitle A of title II of the Americans with Disabilities Act (42 U.S.C. 12131-12134), which prohibits discrimination on the basis on disability by public agencies.

- Publish and broadcast radio, newspaper, television, or mailings of the notice, as well as the name and contact information for the ADA coordinator.
- Increase outreach to people with disabilities and the organizations that serve them to provide information about possible modifications and the accessibility of services, programs, and activities.
- Ensure staff is aware of the public locations of the nondiscrimination statement and the procedure for filing a disability discrimination complaint.

Printed Information

- Include the following notice on materials printed by ACHD that are made available to the public:

This publication can be made available in alternative formats, such as large print, braille, or electronic format. Requests can be made by calling Ryan Fisher at (208) 387-6228, or by using the 711 Telecommunications Relay Service. Please allow 48 hours for your request to be processed.

- Provide instruction to each department on how to produce printed information in alternative formats for persons with various disabilities to ensure that requests are handled in a uniform and consistent manner.
- Produce documents and publications with easy-to-understand language, where possible.
- Include images of people with disabilities when images of people are included in ACHD's printed materials.

Television and Audiovisual Information

- Review ACHD presentations, videos, and recordings of meetings to identify potential barriers to accessibility and corresponding solutions. Closed captioning is not required, but it is a common way of making televised and audiovisual presentations accessible to people who are unable to hear the audio portion, and in some instances, it might be the only accessible format.
- Encourage presenters to read the slides and describe the graphic content when presenting PowerPoint or other visual presentations.
- Include images of people with disabilities when images of people are included in audiovisual materials.

Website

- Publish the Policy of Nondiscrimination, including on the Basis of Disability, on the ACHD website.
- Provide information on ACHD's website about the accessibility of its facilities.
- Conduct web accessibility analyses to periodically measure the accessibility of ACHD's website. This can include outreach to people with disabilities to identify website barriers. Consider adopting standards that meet or exceed Section 508 of the Rehabilitation Act guidelines for the accessibility of electronic information.
- Acquire the technological resources or staffing expertise to create accessible documents for posting on the City website.
- Assign one department the authority to provide standards and oversight for outside vendors who create webpages and for departments who post their own documents.

Telephones and Communication Devices

- Explore options for Video Remote Interpreting Services (VRI) for communicating with people who are deaf, have hearing loss, or speech disorders. There are many situations where a live interpreter is required, such as in medical situations, but VRI can be a convenient, flexible, lower-cost alternative to live interpreters where appropriate.

Training and Staffing

- Develop a comprehensive staff training program to educate all staff about their responsibilities under the ADA. Describe ACHD's policy on inclusion and nondiscrimination.
- Provide training to maintenance staff with respect to accessibility compliance and building codes to maintain facilities in an accessible condition.

- Provide training to staff and contractors responsible for constructing and maintaining the public right-of-way to ensure accessibility during projects.
- Provide training to staff who interact with the public about how to provide modifications and use assistive devices to ensure the accessibility of ACHD programs, activities, and services. Include information about communicating with people with a variety of disabilities.
- Offer training to staff members who have contact with the public and wish to learn basic ASL communication skills. Training should emphasize basic communication and should not be viewed as a substitute for utilizing qualified ASL interpreters when requested.

Program Participation

- Increase outreach to people with disabilities and the organizations that serve them to ensure program accessibility. ACHD should also inform the public of the possible modifications that can be provided to make programs, services, and activities accessible.

Program Eligibility Requirements and Admission

- Include the statement of nondiscrimination on application or registration forms.
- Include information about requesting modifications in application or registration materials.

Public Meetings

- Include information about requesting modifications on agendas or in meeting materials.
- Maintain a list of accessible meeting spaces to facilitate the scheduling of meetings or the relocation of meetings upon request.
- Move disability-related agenda items to the beginning of agendas when possible. Some people with disabilities are unable to stay late at meetings because they use para-transit, have fixed schedules, and/or need to use personal care attendants.
- Maintain a list of on-call ASL interpreters who may be brought to meetings to assist individuals with hearing impairments.
- Provide instruction to staff on the types of modification requests that may be made by persons with different types of disabilities, including assistive listening systems, sign language interpreters, readers, descriptive services, and other assistive technologies like real-time captioning.
- Develop a checklist and provide instruction to staff on ensuring the accessibility of meetings. Guidance should address elements like the layout of the room, sign-in table, and refreshments table. Other considerations should include an accessible path-of-travel to the meeting room, accessible restrooms, accessible parking, and an accessible route from transit and parking to the meeting facility.
- Assign staff as a greeter at public meetings and events. Identify the staff member as a resource for persons who may require assistance.

Transportation Services

- Assess the Commuteride vanpool fleet to determine an appropriate strategy for accessibility. Vanpools are considered a “Demand Responsive” type of transportation

under federal transit laws and are defined in Title 49, Subtitle A, Part 37, Subpart B, §37.31. Other applicable regulations for Demand Responsive services include Part 37, Subpart A, Subpart B, Subpart C (Appendix A), Subpart D, and Subpart G; Part 27, Subpart A and Subpart C; and Part 38, Subpart B.

Tours and Trips

- Incorporate opportunities to request accessibility modifications in registration materials.
- Provide information to participants in advance of a tour or trip regarding the destination, transportation method, and other characteristics of the activity so that informed requests for modifications can be made.
- Evaluate tours or trips to determine accessibility and any modifications that may be required. If a tour route or a portion of a route is inaccessible and modifications are requested, reroute the tour or provide modifications that allow the tour to be experienced in alternative forms (for example: photographs, videos with closed captioning).

Contracting, Licensing, or Other Arrangements

- Monitor services, programs, and activities provided by contractors, licensees, consultants, and other entities to ensure continued accessibility.

Emergency Evacuation Procedures

- Test the evacuation procedures with periodic drills, both announced and unannounced. Enlist people with different disabilities to role-play during emergency simulations.
- Review existing procedures dealing with emergencies to ensure that people with disabilities can be alerted and that they can alert emergency service providers.
- Work with disability organizations to explore the use of technologies such as audible exit signs for orientation and direction or vibrating paging systems.
- Review suggestions for evacuation plans and procedures on the U.S. Access Board website at <http://www.ada.gov/emergencyprepguide.htm>. As applicable, review other resources such as the Procedures for Employees with Disabilities in Office Occupancies document published by FEMA and the U.S. Fire Administration.

Facilities

- Provide information about the accessibility of ACHD facilities on the agency website.
- Record and monitor requests relating to facility access. The ADA Coordinator can analyze accessibility requests periodically to look for global issues that can be addressed and problems that can be solved proactively.

Special Events and Private Events on Public Properties

- Inform private organizations that coordinate or sponsor events at ACHD facilities about applicable ADA requirements.
- Provide a checklist and information during the application process to inform organizers of their responsibility for accessibility under the ADA.
