Escort and security services are required at a reasonable time prior to the start of the event until a time when all traffic obstructions have been removed and spectators have been safely dispersed.
- 4. The applicant will provide liability insurance and attach a copy of the policy to this application. Garden City and Ada County highway District must be listed as Additional Named Insured Parties.
